AICC/BOARD CONVERTING INNOVATOR OF THE YEAR ENTRY RULES AND GUIDELINES

ENTRY RULES

Competition Eligibility

The Innovator of the Year Competition (Non-Machinery) is open to all AICC Associate (supplier) Members. Nonmembers are not eligible.

Entry Requirements

Entrants must complete the official entry form and provide a VHS videotape of the entry.

Video Requirements

Entrants must provide a VHS videotape (NTSC format) of the entry that runs no longer than 5 minutes. Off-screen narration must be included on the video for purposes of clarifying the action on the screen but will be voiced over in the final video presentation to the AICC membership. A second person should hold up or demonstrate the entry and point out its attributes. Please try to eliminate any company references or logos in your video.

Entry Fees

Entry fees are not required to enter the competition.

Multiple Entries

Companies may enter more than one entry into the competition provided that each entry includes its own completed entry form and VHS videotape.

Judging

Entries submitted into the Innovator of the Year Competition are first judged by a panel of AICC members who make up the Plant Innovations Committee. Six finalists are chosen and featured at the AICC Annual Fall Meeting General Session during which attendees vote by secret ballot for the Innovator of the Year. Winners are announced at the meeting's closing General Session.

COMPETITION AWARDS

First Place / Innovator of the Year

The First Place Winner is designated the Innovator of the Year and awarded the competition's Silver Trophy Bowl, a complimentary registration to the next national meeting and the video of the winning and finalist entries.

Second Place

The Second Place winner is the recipient of an awards plaque noting their achievement and receives a copy of the video of the winning and finalist entries.

Third Place

The Third Place winner is the recipient of an awards plaque noting their achievement and receives a copy of the video of the winning and finalist entries.

Finalists and Honorable Mentions

Finalists and Honorable Mentions receive a certificate noting their participation in the competition. In addition, all finalists receive a copy of the video of the winning and finalist entries.

VIDEO GUIDELINES

1. Use the highest grade videotape available.
2. Use additional lighting when possible. The more light, the better the video quality.
3. To avoid a "shaky" video picture, mount the video camera on a tripod or if one is unavailable, use a very steady hand.
4. During the taping, have another person demonstrate or show how the entry works. Show the entry/demonstrator in a "wide shot" and a "close shot." The demonstrator should NOT talk.
5. During the taping, have a second person (not the camera operator) stand off-screen by the camera and verbally describe the action and/or entry.
6. **Videos must be limited to 5 minutes.**
7. When done shooting the video, DO NOT edit the video. AICC will use the footage needed.
8. While judging will be based on the merit of your entry and not on the professionalism of the video, please note that a good video (i.e., shot in better lighting; not shaky, clear picture) and a well-explained (through the entry form and off-camera narration) entry can only help when your entry is judged.
